You Do Make A Difference

In your membership renewal packets there is a letter urging you to contribute to the Veterinary Medicine Political Action Committee(VMPAC)and there is also a line on your renewal statement where you can make the donation. Let me share some facts that might stimulate your generous contributions to the VMPAC (which supports the legislative activities of the ISVMA).

- Animal rights organizations are very effective fundraisers:
 - The Humane Society of the United States/Fund for Animals raised an astounding \$130.2 MILLION dollars in 2006.
 - People for the Ethical Treatment of Animals (PETA) raised \$30.2 MILLION dollars in 2006.
- The number of lawyers specializing in animal rights defense and plaintiff's cases against animal caregivers is rapidly growing:
 - There are 1,143,350 licensed and practicing attorneys in the United States and approximately 85,000 veterinarians. If you extrapolate the numbers, it means that there are an estimated 13.5 lawyers to every ISVMA member in Illinois.

Veterinarians must be vigilant and proactive in defense of the rich history and tremendous accomplishments of the veterinary profession. The ISVMA is the voice of the veterinary profession in Springfield - where most of the laws and regulations that affect the profession are decided. ISVMA is a very effective advocate, but we could do better with more grassroots (member) support.

That Is What Makes Us Unique

"They all support what we are really about; what makes ISVMA unique."

That was my comment to the ISVMA Board of Directors meeting on April 9, 2008 as we discussed budget assumptions for the next fiscal year. I was referring to the income sources (dues, annual conference, royalty

programs, sponsorships, etc.) that sustain the association and allow us to fulfill our unique mission. This mission stimulated the formation of ISVMA in 1883 and is still guiding us today - **the need to share individual learning experiences with col-leagues and discredit unqualified practice.**

No other organization is organized to advocate for the veterinary profession in the State of Illinois. Neither is any other organization capable of providing you with representation before the state legislature, executive offices and regulatory agencies. Our strength comes from our members; and the more our members participate, the stronger we become.

ISVMA recently held its Fourth Annual Lobby Day. As has been the case each year, the camaraderie and enthusiasm of participants was one of the highlights. This year, our volunteer lobbyists included seven students from the College of

Veterinary Medicine. Their participation was very welcomed and their contribution was profound! Lobby Day participants were able to visit with 53 different legislators. The feedback we have received from those legislators has been outstanding. They very much appreciated the veterinarians and veterinary students that took the time to communicate with them and help inform them on the issues that are important to the profession.

Two of the bills we advocated on Lobby Day passed the House of Representatives and were sent to the Senate for consideration. Several of our Lobby Day participants were able to convince their legislators to become sponsors of the bills in the Senate and every legislator we talked to planned to support our bills. We even had a legislator volunteer to one of our veterinary students that he would like to include funding for the proposed veterinary school building project in the State's capital budget. The student that visited this Senator doesn't even live in his district. Her only connection to him was giving him and his daughter a tour of the veterinary school a few weeks earlier.

In 2005, the Auxiliary to the ISVMA began a new fundraising effort to help support its Auxiliary to the Illinois State Veterinary Medical Association Student Scholarship Fund. The fund allows for the annual presentation of \$1000 scholarships to veterinary students at the University of Illinois-College of Veterinary Medicine, a total of 27 awarded to date. This natural/black wrap and blue fill blanket, made by Manual Woodworkers and Weavers of Hendersonville, NC, measures 46" X 67" and features images representative of the campus and the College of Veterinary Medicine. They include:

Spring Clinic, 1891 Marking the beginning.


First Veterinary Classrooms, 1948 The 1948 building was a former sorority house that still stands at 805 West Pennsylvania in Urbana.

The Round Dairy Barns

These round barns are the inspiration of Wilbur J. Fraser, the first head of the Department of Dairy Husbandry (1902 to 1913). Fraser was a strong advocate of round barns, which offered the dairy farmer "economy of consideration, low maintenance, and labor efficiency." He also cited the barns' better ability to withstand prairie windstorms. Fraser and the University's demonstration barns were apparently instrumental in popularizing the round barn type found throughout Illinois. The first barn was built in 1907-08; the second and third about 1910.

Dr. Moolittle

Dr. Moolittle was the College's entry into the Chicago "Cows on Parade" public art exhibit in 1999.



The Alma Mater

The Alma Mater is shown "as a benign and majestic woman in scholastic robes, who rises from her throne and advances a step with outstretched arms, a gesture of generously greeting her children" (Taft). Learning and Labor flank the main figure. An inscription reads: To thy happy children of the future those of the past send greetings.

Service and Education

This panel is representative of the veterinary program at the U of I campus. The student with the dog is Christina Villarete from the class of 2000.

Wildlife Medical Center

This panel reminds us that wildlife need care and treatment to the point where they can be returned to the wild. The student pictured with the hawk is Dana Rzechula, class of 1990.

Basic Sciences Building, 1983 Marking the future

AAEP RELEASES UPDATED EQUINE VACCINATION GUIDELINES

In January 2008 the Infectious Disease Committee of the American Association of Equine Practitioners (AAEP) issued revised guidelines for the administration of vaccinations to horses based on the age of the horse and its previous vaccination history. The guidelines are intended to serve as a reference for veterinarians as they employ vaccines in their respective practices.

Highlights of "Guidelines for the Vaccination of Horses" include:

- The identification of tetanus, Eastern/Western Equine Encephalomyelitis, West Nile virus and rabies as "core" vaccines.
- The addition of a vaccination protocol for anthrax.
- Recommendations for the storage and handling of vaccines, vaccine labeling and adverse reactions.

The Committee, comprised of researchers, vaccine manufacturers and private practitioners, updated guidelines that were established by the AAEP in 2001. The complete document, along with easy reference charts, is available on the AAEP Web site at www.aaep.org/vaccination_guidelines.htm.

PAIN MANAGEMENT IS GOOD MEDICINE

In the November 2007 issue of Veterinary Medicine, Robin Downing, DVM wrote in her article entitled "Putting the new pain management guidelines into practice" that by practicing good pain management, veterinarians demonstrate their compassion for not only their patients but for their clients as well. Not only is this consistent with good veterinary medicine, managing pain can also be good business. "Increased compassion builds relationships with clients and bonds those clients to the practice. This commitment to doing more for our patients leads to increased client visits and increased revenues."

To assist in making pain management determinations for canine and feline patients, the American Animal Hospital Association (AAHA) and the American Association of Feline Practitioners (AAFP) published new guidelines for pain management in September 2007, covering types of pain, anticipation and early intervention, recognition and assessment, pharmacological and nonpharmacological intervention, what to do when pain persists and client/staff education.

POSTAL RATES INCREASE IN MAY

The United States Postal Service (USPS) will be adjusting prices on May 12, 2008 for their mailing and shipping services - Express Mail, Priority Mail, Parcel Select, Parcel Return Service, and International Mail.

The price for a first class stamp will increase from 41 cents to 42 cents. The Forever Stamp will be able to be used at any time, even if purchased at the 41 cent rate. The stamps were created to make price transitions less confusing. As their name indicates, they are good forever regardless of the price paid for them. Five billion Forever Stamps will be in stock to meet the anticipated demand before the price changes.

The USPS for the first time will offer pricing incentives to make their shipping more attractive to all shippers, especially small businesses. Express Mail switches to a zonebased system, resulting in customers paying less for nearby destinations. If purchasing Express Mail online or through corporate accounts, customers will receive a 3 percent price reduction. Customers who use electronic postage for Priority Mail will have an average 3.5 percent savings. Parcel Return Service will move entirely to a weight based pricing system, allowing price reductions for many lighter packages.

AMERICAN HEARTWORM SOCIETY ADDS NEW FEATURES TO WEB SITE

The American Heartworm Society (AHS) has announced an update to its Website, <u>www.heartwormsociety.org.</u> New member benefits include the ability to submit heartworm-related questions online and receive answers from the Society's expert panel. Their quarterly e-bulletin will also be posted and archived for members. Two new games have been added to the Just for Kids section.



From Today's Students, Tomorrow's Research Leaders

Herb Whiteley, DVM - Dean, University of Illinois - College of Veterinary Medicine



It takes no more than a walk through the Zuschlag/ISVMA Veterinary Heritage Collection to see how veterinary research has benefited society and elevated our profession. From the discovery and eradiation of hog cholera to present-day work on transmissible spongiform encephalopathies and a host of other biomedical concerns, veterinarians who engage in research have improved lives worldwide.

They have also formed the basis for current veterinary practice and provided continual advances to benefit our patients.

Veterinary researchers are in demand in academia, in government, and in industry.

Yet the need for veterinary researchers greatly outstrips the supply. A 2005 report from the National Research Council said this shortage is "due partially to declining interests in research among veterinary students." Their lack of interest, in turn, is attributable to the huge investment in time and money required to pursue a DVM and PhD, the little financial support for such students, and the minimal exposure to research provided to veterinary students. (1)

The College of Veterinary Medicine has been working hard to address this problem. To expose more veterinary students to research activities, we have conducted summer research programs for the past five years through our Center for Zoonoses Research. This program now has funding through Merck-Merial and the National Institutes of Health.

Nevertheless financial support for students will be the real key for encouraging budding researchers within our profession. We are presently revitalizing our Vet Med Scholars Program, which provides tuition waivers and stipends for veterinary students who simultaneously pursue a PhD.

When 254 prospective members of the Class of 2012 interviewed at the College on February 18, thirty applicants sought out Dr. Ned Hahn, associate dean for research and graduate studies, to discuss the Vet Med Scholars Program.

"They were a very diverse crowd," he reports, with interests ranging from engineering to snake immunology.

More than 40 of the applicants accepted into the DVM program in February were sent graduate program application materials. In mid April we will review the applications and invite two or three incoming students with demonstrated research interest into the Vet Med Scholars Program.

For our College in this era of budgetary austerity, investing in student-scholars is a significant financial commitment. Yet we recognize the potential risks if the need for veterinary researchers goes unmet. Who will address mounting concerns about national biosecurity and public health? Who will make discoveries to improve animal and human health? Who will teach future generations of veterinary students?



If we succeed in fostering veterinary researchers, someday soon we will be adding to the Zuschlag/ISVMA Heritage Collection. We will extend the story of Illinois contributions to the veterinary profession with a new cabinet highlighting the work of our veterinary scholar alumni.

What Do Your Employees Expect of You?

A healthy employee:employer relationship is dependent on shared understanding of expectations and responsibilities on the part of both parties. To learn more about the expectations that veterinary employees have of their bosses ... I simply asked them!

I led a session entitled "Help My Boss Doesn't Understand Me?" at the 2007 ISVMA Annual Convention and I asked the session attendees to complete the following two sentences:

I really like it when my boss ...

I really do not like it when my boss ...

Before I tell you their responses, I'd like to share some thoughts from Patti Holmes, President of Holmes Training and Development in Oxford, OH. (Ms. Holmes is a professional speaker and consultant specializing in leadership and organizational transformation and past presenter to the Executive Veterinary Program - Small Animal Reunion Group)

After fifteen years of consulting with businesses of varying types and size, Holmes detailed her findings in her book, *What Do Followers Expect of Leaders*. She found that employee expectations usually fall into one of these six categories:

- Communicate Effectively
- Create a Positive Environment
- Model the Way
- Strengthen Personal Skills
- Inspire and Motivate
- Be a Master Teacher

With this as background, let's look at what your employees had to say about you!

I really like it when my boss ...

- ... recognizes my work and my accomplishments.
- ... acknowledges I'm there actually working for him.
- ... is having a good day when he is nice and rewards me with a "Good Job!" compliment.
- ... praises/compliments me for a job well done (tough case, etc.).
- ... has taken the day off work.
- ... appreciates what the entire staff does and praises the staff so they know.
- ... leaves 20-60 minutes early when nothing is going on.
- ... is happy with my work.
- ... listens to me, follows my recommendations and shows appreciation for my work.
- ... trusts me to make decisions.
- ... praises me when things turn out right.
- ... lets me run with the ball.
- ... supports my opinions/actions in front of clients/co-workers.
- ... goes with one of my ideas.
- ... runs a <u>very</u> flexible office (As long as the work is done and office is covered, I can attend doctor's appointments, kids' activities, etc.)

I really do not like it when my boss ...

- ... does not give me clear goals.
- ... becomes short with me.
- ... ignores me, or becomes angry with me for asking questions.
- ... is stressed and/or irritable.

- ... tells us that we do a good job, however, you need to do it this way - this is not your job, but our passion!
- ... second guesses.
- ... stresses over nothing.
- ... criticizes me for everything I do!
- ... has tunnel vision.
- ... does not listen to the full problem before offering a solution.
- ... micro manages needs to let me sweat the small stuff.
- ... doesn't say thank you or good idea (I know they pay me, but positive reinforcement will get even more work out of me!).
- ... takes my work for granted overtime, etc.
- ... gives vague answers.
- ... gives me management duties, but won't give me the title or authority to back it up.

So ... these are the things you do that either please, or displease, your employees. And ... each response easily fits into one of Holmes' six categories.

If you think one of your employees could be responding as above to the second question, don't be too hard on yourself. Use this as a learning experience! Harvard's John Kotter, in *What Leaders Really Do*, calls the relationship between an employee and his/her boss as one of ... "mutual dependence between two fallible human beings". You're human!

I suggest you post Holmes' six categories of employee expectations above your desk. Review it each day and you will be on your way to a healthier and more satisfying relationship with your employees.

Remember, you don't want to be the boss whose employee remarked to Holmes ... "Don't light up the office ... by leaving it!"

New Specialty Association Formed

The American Association of Rehabilitation Veterinarians has formed and will be holding its first annual meeting from Aug. 13-16 in Minneapolis.

The secretary and founder, Dr. Julia Tomlinson, owns Twin Cities Animal Rehabilitation Clinic in Burnsville, Minn. Dr. Tomlinson said the rehabilitation of animals is a growing business, involving veterinarians and non-veterinarians. In addition to clinics that provide specialty surgery and rehabilitation, an increasing number of clinics focus solely on rehabilitation. Providing rehabilitation as part of mainstream practice permits veterinarians to take a central role in case management.

The goals of the AARV are to help advance rehabilitation in veterinary medicine, increase public awareness of veterinary rehabilitation, and allow rehabilitation veterinarians to meet and discuss aspects of continuing education. Dr. Tomlinson said recent scientific articles have reported the advantage of rehabilitation in recovery from orthopedic surgery and in management of chronic arthritis. New guidelines from the American Animal Hospital Association recognize the role of rehabilitation in pain management protocols.

Association of Reptile and Amphibian Veterinarians Petitioning the ABVP for Recognition

The AVMA American Board of Veterinary Specialties has received a petition for recognition of the Reptile and Amphibian Practice specialty. To comply with ABVS procedures for recognition of a new specialty, comments are being sought from the public and the profession regarding the proposed new specialty.

The process began in 2006 with the Association of Reptile and Amphibian Veterinarians petitioning the ABVP for recognition as a specialty. Their formal petition was submitted in December 2007 to the ABVS Committee on the Development of New Specialties. The proposal is supported by the belief that the diverse and unique veterinary requirements of reptiles and amphibians - including iguana, turtles, snakes, frogs and toads - are substantial enough to warrant separate specialty recognition. Over 175 current members of the Association of Reptile and Amphibian Veterinarians have indicated they would pursue board certification in the **ABVP Reptile and Amphibian Practice** specialty once it was recognized.

Out of more than 2100 ISVMA members, only 132 (6%) contributed to VMPAC. The average contribution was \$74.07; resulting in a total contribution of \$9777.50. By contrast, 65% of the members of the ISVMA Board of Directors contributed to VMPAC (I am working to make that 100% before I leave office.) As the VMPAC Chairman (Dr. George Richards) will tell you, "PAC money does not buy us votes; but it does buy us access. VMPAC purchases tickets to political fundraisers, receptions and events for legislators that have supported our political agenda or with whom we hope to develop stronger relationships. Veterinarians from the legislators' districts are invited and encouraged by VMPAC to use the tickets and attend the events in order to thank the legislators for their support. Developing these personal relationships between local veterinarians and their legislators has been a key component to our recent advocacy successes."

ISVMA has worked hard to expand our grassroots political effort. Member involvement has been crucial in our success on a number of recent issues affecting veterinary medicine in Illinois:

- ISVMA succeeded in pushing the state to develop a comprehensive and understandable regulation on veterinary sales tax application.
- ISVMA succeeded in defeating a poorly conceived "informed consent" bill.
- ISVMA contributed to the defeat of legislation that proposed banning specific dog breeds.
- ISVMA has defended the veterinarian's scope of practice and fought against the unauthorized practice of veterinary medicine. - ISVMA is working to pass the Veterinary Student Loan Forgiveness Program Act which would support veterinary graduates
- willing to practice in areas of critical need such as food animal, regulatory or food inspection medicine in Illinois.
- ISVMA is working to pass legislation which addresses the concerns that medical professionals have with Internet prescribers sending prescription medicine without appropriate medical evaluation, communication and recordkeeping. In the case of veterinary medicine, the legislation supports the legal requirement for the establishment of a Valid Client Patient Relationship (VCPR) before a prescription can be written.
- And much, much more.





Can I Make a Difference?

Other than a photograph, very few things speak loudly to a community. As an individual, and sometimes as a group, to really be heard it typically means your actions must speak for you. The ISVMA repeatedly encourages its members to become part of the voice of veterinary medicine in Illinois by being active in state government issues. Our association offers multiple ways to do this, even for those members who have no background in politics.

Becoming active in politics may be a step outside of a comfort zone, like standing before a crowded room to speak; however, every journey begins with just one step in the right direction. In an article by Phillip M. Perry in his article entitled "Local Politics" (Beef Magazine, January 2008), he quotes Al Arnold, director of the Academy of Local Politics, Rice Lake, WI. "Politics is a game. In order to be successful in any game, you need to know the rules."

One of the most important rules pertains to personal networks. The ISVMA every year reminds its members to fill out and return a Legislative Relationship Form. The information compiled from these forms allows the ISVMA to utilize professional, and often personal, relationships to help get things done. Take an example from last year's legislative session. An ISVMA member contacted the executive director and cited a law that prohibited minors under

16 years of age from being employed where there could be exposure to animal blood, animal blood products, animal body fluids or animal body tissues. They had a student who wanted to work in their kennels and, by law, this 15-year-old could not pursue their desire to work around animals. The law as it stood had language that did not differentiate between human and animal exposure. Through the work of the ISVMA office, and the extensive networking done by ISVMA members to educate legislators of Illinois, language was introduced to make this section of the Child Labor Law specific. The bill passed unanimously in both houses and in September of 2007, Public Act 95-0180 was passed allowing minors under 16 to work under these conditions.

Are you uncertain who your representatives are? ISVMA has a very simple tool called CapWiz to help you learn this and obtain contact information. Capwiz is a software program on the ISVMA website that allows members to search for elected officials and communicate with them, monitor legislation at the state and federal level, and keep up to date on elections. It can be found at in the Members' Center of the ISVMA website at www.isvma.org.

To take a first step, try something like sending a letter of introduction. Let your elected official know that you reside in their district, that you are a veterinarian and would be happy to make yourself available as a resource if they would ever have a question pertaining to animals, food supply, etc. In 2007, an ISVMA legislative intern contacted members of the House of Representatives and Senate. Many of these elected officials commented that they had never thought to confer with a veterinarian on these types of issues. That begs the question; where were these elected officials getting their information?

Pergolide Removed, Then Returned to the Market

On May 11, the Food and Drug Administration (FDA) Center for Veterinary Medicine announced it would allow bulk pergolide to be used in compounding pergolide for use in horses. That's good news - and proof that the FDA listens to the animal health industry.

The equine community didn't stand still when the FDA announced that pergolide mseylate had been withdrawn for human use because of a risk of damage to the heart valves of human patients. Action was initiated because the drug is also used to treat pituitary pars intermedia dysfunction (PPID), also known as equine Cushing's disease. Because pergolide had been withdrawn for its approved use in humans - and compounding of animal drugs from bulk drug is considered illegal, wholesalers would have had no legal way to bring the drug into the country for compounding use.

After the FDA's withdrawal announcement, the American Association of Equine Practitioners (AAEP) worked to encourage the FDA to provide an exemption for importing bulk pergolide. The AAEP's effort consisted of sharing information and emphasizing the importance of the drug to equine practitioners and their clientele. Horse owners, veterinarians, pharmacists and farriers mounted an online campaign with the petition sent to the FDA and the manufacturers of pergolide mseylate asking for continued production and availability of the drug.

In its May 11 statement, the FDA Center for Veterinary medicine stated: "FDA is working with the sponsors of the approve products and all other interested parties to ensure that pergolide remains available to treat Cushing's Syndrome in horses until a new animal drug application is approved for that use. This includes trying to make the approved product available through veterinary distribution channels and exercising enforcement discretion as appropriate over the pharmacy compounding of pergolide."

Marketing Your Practice to Spanish-Speaking Clients

Legal Consent Forms as a Marketing Tool By James F. Wilson, DVM, JD

Senor and Senora Martinez have just arrived at your veterinary practice with their 12-year-old daughter, Maria and her beloved 6-year-old, small breed, intact, female mutt named "Rosie." As you question the family about the reason Rosie is there, it becomes apparent that her parents speak only limited English. In fact, nearly all questions and answers have to be directed through Maria.

As a result of your questions, and interpretations of the facts provided by Maria, it becomes likely that Rosie is suffering from a pyometra. Your examination reflects this likelihood but you still need to confirm it and determine whether Rosie will tolerate an ovariohysterectomy. Thus, you recommend a CVC, abdominal radiographs, and a blood chemistry panel.

It is clear by Maria's reaction to your fact finding and questions asked through her to her parents, that the family is struggling with the diagnosis. The situation becomes even more difficult as you try to explain the risks and costs of anesthesia and surgery. In fact, you are quickly becoming frustrated by the amount of time it is requiring, which you are sure would have been diminished remarkably if only these clients spoke fluent English. You worry that the family will never understand the risks associated with surgery and cannot understand the need for a medical work up nor why you have outlined the range of fees.

With the population of Spanish-speaking Americans approaching 14 percent in 2007, how many of you in practice today are experiencing situations like this with increasing frequency? From what I hear, this scenario is now common in every state in the USA. In fact, in some trade areas the same dilemmas occur with Americans who speak an assortment of Asian, Russian and eastern European languages.

DIVERSITY IN AMERICA

As anyone who travels through the United States knows, diversity is everywhere. I log nearly 100,000 air miles each year and am amazed by the volume of travelers speaking something other than English. When I fly through Miami, I often wonder if I'm really in the U.S. of A. However, based on the people greeting all these passengers or saying good bye at airports, the majority of these travelers reside in this country.

Each year for the past three years, Pfizer has sponsored a terrific "Diversity Symposium" at the AVMA Convention. I was able to attend nearly all of that full day seminar this past July in Washington, D.C. It became apparent that veterinary practices that would like to expand their businesses don't have to look very far to do so. All they have to do is cater to and make life easier for animal owners who speak foreign languages. This is as true for the small animal practices as it is for large animal veterinarians who render care to horses and food animals, where the majority of caregivers now speak a foreign language.

What are you doing to tap into that market?

A GREAT STARTING POINT

Experience has taught me that as soon as any group of people has a modest amount of disposable income, they purchase veterinary care for their bonded pets. They also

seek to be educated about the care expected of them as owners. This is because the strength and power of the human-animal bond cuts across all nationalities and economic barriers. The biggest problem in the U.S. is that very few veterinarians or practice health care team members speak anything other than English. Moreover, because they haven't seen minority populations as a source of growth for their practices, they don't hire bilingual staff who can. Even more problematic, they provide little or no educational materials in anything except English.

When I revised the third edition of the Legal Consents for Veterinary Practices in 2006 and added 25 new forms to the fourth edition, I listened to Rick Alampi, executive director of the New Jersey VMA. He said, "Jim, our association members here in New Jersey are struggling with the inability to communicate effectively with the rapid growth in the numbers of their Spanish-speaking clients. If this is a problem in New Jersey, can you imagine how big the problem is in many of the other states?" We ultimately agreed that if this book of forms was translated into Spanish, the NJVMA would purchase 150 of them and provide them at no charge to the first 150 practices that requested them. The association did so and they were gone in three days.

It was that initial conversation with Mr. Alampi that led to the quest to find a firm that could handle the task of translating the nuances of medical and legal terminology from English to Spanish. My publishing partner and wife, Elise, did just that and we found a firm that had been translating important documents into other languages for over 20 years.

Although I have always felt that the individual forms in this publication could be used to market one's practice, it wasn't until I sat through the Pfizer Diversity Seminar that the full impact of this idea hit me. My question that day became, "Why don't practices with significant Spanish speaking clients do four things:

- 1. Advertise in the Yellow Pages or local Spanish print media the fact they provide educational and legal consent forms in English and Spanish.
- 2. Develop a section on their practices' web site written in Spanish that welcomes Spanish-speaking clients and includes all or portions of several of the basic legal consents in Spanish.
- 3. Hire a bilingual person to work a minimum of half time and advertise these hours. This way, when these clients arrive, they can immediately communicate with a staff member in their native language so they don't have to rely solely on their young children to serve as their interpreters.
- 4. Have a Legal Consents book with English versions of the forms on the left page and Spanish versions on the right available at the front desk. This allows the practice's receptionists or customer service reps to educate clients about the procedures that will be performed with ease. The forms that could provide the most value include: 1) the initial patient admissions, 2) the estimated costs for care, 3) authorizations for surgery, dentistry, acupuncture, ultrasound aided biopsies, and laboratory tests, 4) CPR and do not resuscitate orders, 5) under standing the risks related to the use of NSAIDS and the need for regular blood tests for patients receiving them, 6) complicated vs. simple consents for euthanasia procedures and the public health risks related to various courses of action, 7) daycare and boarding procedures, 8) issues surrounding the admin istration of core and noncore vaccines, and 9) the use of extra label and compounded drugs.

CONCLUSON

Opportunities exist throughout America to expand the quality and quantity of veterinary care to an increasingly diverse population. These animal owners love their pets as much as the English-speaking owners do. As their numbers and disposable incomes grow, they are seeking public and animal health education and veterinary services just like everyone else in your practice.

Why not become the first practice in your area to fuel this potential growth engine? All you have to do is tout your willingness to serve the Hispanic population in your location by offering educational forms and other materials in Spanish. As an added bonus, once you have done this, you will have added a terrific supplement to your

It is vital that we keep in mind that the deadline for renewal of The Veterinary Medicine and Surgery Practice Act is rapidly approaching. ISVMA has been working hard to create relationships with the legislators so that we can make improvements to this law that establishes and guides the veterinary profession. A coalition of alternative and complementary therapy providers held our Practice Act hostage during the last renewal (in 2003) and threatened to allow it to expire if we did not accept their amendments diminishing the scope of veterinary practice. To quard against that happening again, the ISVMA is developing strategies and recommendations for improving the Practice Act and defending it against those that would further diminish the scope of practice.

Please reflect on just how much practicing veterinary medicine in the state of Illinois means to you. Are you willing to invest a small amount to see that we can continue to aggressively guard our Practice Act and the very profession that we all know and love? I hope so. This is, "Your Profession, Your ISVMA."

READERS' FORUM

Q: A client recently purchased a prescription medication from our clinic and now wants to return it for a refund, is this legal?

A: No, according to the rules and regulations for the Illinois Pharmacy Practice Act; "Pharmacists and pharmacies are prohibited from accepting from patients or their agents for reuse, reissue or resale any dispensed medications, chemicals, poisons or medical devices except for: 1) medical devices that can be properly sanitized prior to reuse, resale or rerent; and 2) Medications and medical devises that are dispensed and stored under conditions defined and supervised by the pharmacist and are unopened in sealed, intact and unaltered containers that meet the standards for light, moisture and air permeation as defined by the current United States Pharmacopoeia (USP)/National Formulary or by the United States Pharmacopoeia Convention, Inc." (Title 68, Professions and Occupations, Chapter VII: Department of Financial and Professional Regulation, Part 1330 Pharmacy Practice Act of 1987, Section 1330.91, Subsection f).

Q: We have a client who is challenging our hospital policy. We will not sell heartworm preventative without having run a heartworm test for an animal. They are refusing the test and demanding we sell them the heartguard preventative. Are we within our legal rights to withhold selling the medicine?

A: From the manufacturer of the medicine to various professional societies, all experts specify that heartworm preventative is to be used jointly with the testing done in your practice. As stated by the American Heartworm Society (<u>www.heartworm</u> <u>society.org</u>), "Before starting a preventive program, all dogs that could possibly be infected with mature heartworms should be tested. Giving heartworm preventives to dogs who have heartworms can lead to severe reactions that could be harmful or even fatal to the dog."

Q: We have an animal that has been abandoned. If we follow all that the Practice Act specifies, and the animal has not been claimed, do we have to destroy the animal?

A: The text of the Practice Act does not specify that the animal has to be destroyed. The following is part of what is specified in the Veterinary Medicine and Surgery Practice Act of 2004 (225 ILCS 115/18) This is what is written:

"Sec. 18. Unless otherwise contractually provided between veterinarian and client, a veterinarian may dispose of any animal abandoned in his establishment, provided he shall give notice of his intention to do so to the owner at the last-known address by certified mail, return receipt requested, and shall allow a period of 7 days to elapse after the receipt is returned before disposing of such animal. But if the owner cannot be located at such address, the veterinarian shall give such notice by publication in a newspaper published and having a circulation in the area in which such owner was last known to reside and shall allow a period of 7 days to elapse after such publication before disposing of such animal."
