

## THE VETERINARIAN'S ROLE IN PUBLIC POLICY

I began my professional career as a policy analyst for the Illinois House of Representatives and also spent 15 years as a lobbyist. I learned through that experience that legislators value the information they receive from experts and practitioners. The legislature is well represented by lawyers, farmers, smallbusinessmen, teachers and other professionals. Not one of them, however, is a veterinarian or an expert in veterinary medicine. Legislators depend upon facts and data to make good decisions. When they make bad decisions, it is often the result of either poor or a complete lack of information.

Veterinarians are uniquely qualified to provide information, service and advocacy on important public policy issues including animal welfare, animal health, food-safety, public safety from zoonotic diseases and bioterrorism security. The expertise of the state's 2700 licensed and practicing veterinarians is critical in the development of effective public policy. ISVMA gives veterinarians a voice to assert their influence.

The absence of veterinary expertise on the floor of the Illinois Senate and House of Representatives creates an information vacuum that should be filled by veterinarians. If the veterinarians of Illinois don't offer an opinion on issues of importance to their profession, somebody else will.


Only 18 months ago, a group of well-funded and motivated non-veterinarians were able to hold the Veterinary Medicine and Surgery Practice Act hostage in an effort to obtain concessions that would allow non-veterinarians to engage in activities that were traditionally viewed as the practice of veterinary medicine and were restricted to licensed veterinarians. The threats to professional veterinary medicine continue to grow and veterinarians must become increasingly involved in the exchange of facts and data with legislators and regulators who are responsible for establishing public policy.

ISVMA has expended tremendous effort to build the capacity necessary to fill the information void in the legislature. The E-SOURCE Newsletter (distributed by e-mail) will keep ISVMA members informed of critical issues and timely information necessary for veterinarians to become effective advocates. We're building a database of relationships between veterinarians and elected officials. Almost every elected official either has a family veterinarian or knows a veterinarian. We've been trying to identify those relationships so we know which veterinarians can "get the ear" of any legislator. We've also worked hard to help veterinarians understand their important role in public policy.

Legislators count on us for to help them make good decisions. As ISVMA members fill that need, they will advance the well being of veterinarians, animals, the public and the environment.

#### "Potentially Infectious Medical Waste — A Summary of Regulatory Requirements"

Due to questions that have come through the ISVMA offices this past month, we are making available to our members information supplied through the Illinois Environmental Protection Agency. The brochure, "Potentially Infectious Medical Waste -- A Summary of Regulatory Requirements", gives an overview of the general requirements prescribing the standards and criteria for the handling of Potentially Infectious Medical Waste (PIMW). The requirements found in the Illinois Environmental Protection Act, and the Illinois Pollution Control Board's regulations, are listed in this brochure with the intent to inform to reduce the occupational and environmental health risks that occur during the storage, treatment, transport, transfer, and disposal of PIMW.

**Update on ProHeart®6 Injectible Heartworm Product for Dogs** On September 21, 2004 the Veterinary Drugs Directorate (VDD), a division of Health Canada, the Canadian federal department that oversees health matters, met with representatives from Wyeth/Fort Dodge Animal Health as part of the ongoing post-market surveillance of the veterinary heartworm preventative, ProHeart 6.

Based on Health Canada's assessment at this time, an immediate recall was not warranted for ProHeart 6 in Canada. Health Canada will continue to evaluate the safety data on this product. In particular, the VDD will review American adverse experience data and complementary post-market studies.

two progressive thinking veterinarians, who had the advancement of veterinary clinical practice at heart. Drs. Bill Jackson of Lakeland, Florida (boarded in surgery and ophthalmology) and Don Sawyer of Michigan State (boarded in anesthesiology), conceived the idea of the ABVP<sup>TM</sup> and in March 1977, the concept was presented to the American Board of Veterinary Specialties. In July 1978, the ABVP became a reality. The first examination was given at the AVMA Annual Meeting in St. Louis in July 1981 and there were 41 Diplomates certified that year.

Today, the ABVP has grown to nearly 900 Diplomates, represented by 46 states and eight countries. There are 23 active members in the state of Illinois.

## Tax Credits Available to Employers Hiring Disadvantaged Workers

Planning to hire? Two types of tax credits are now offered to employers who hire and retain disadvantaged workers. The incentives for helping those most in need into the workforce have never been greater. And taking advantage of the new Welfare-to-Work tax credit and the existing Work Opportunity Tax Credits (WOTC) has never been easier.

#### Welfare-to-Work Tax Credit.

Now employers can take as much as \$8,500 directly off your federal income tax by hiring and retaining a long-term welfare recipient. Members of families on public aid for the preceding 18 months earn their new employers up to \$3,500 for their first year on the job and up to \$5,000 for the second year at work. By employing these individuals defined as most in need, you will join the growing ranks of Illinois employers providing jobs to those who face significant barriers to employment ... while enjoying an unprecedented tax break. Perhaps best of all, it can be done by simply completing two forms.

How is the credit calculated? The Welfare-to-Work Tax Credit for new hires employed 400 or more hours or 180 days is 35% of qualified wages for the first year of employment, and 50% for the second year. Qualified wages are capped at \$10,000 per year.

## MESSAGE FROM DEAN HERBERT WHITELEY

University of Illinois College of Veterinary Medicine

Do you know what is located in Urbana that every day helps veterinary practices across the state (and beyond) maintain animal and public health and welfare? Hint: It is located in our College, but has been providing service to veterinarians since about 25 years before the College was founded.

#### The answer: the Veterinary Diagnostic Laboratory.

Even long-time users of these services probably don't realize the scope of VDL's activities and all the ways it can improve the clinical practice of veterinarians.

Between 1995 and 2002, the number of accessions submitted to the laboratory more than doubled and the number of actual laboratory tests performed tripled. VDL now handles more than 42,000 cases a year. Only about one-fourth of these are connected with the College's Veterinary Teaching Hospital. More than 40 percent of the case load pertains to production species, including cattle, swine, sheep, goats and poultry (mainly turkeys), and nearly another 40 percent relates to dogs and cats; the rest relate to horses, other companion animals, wildlife, zoo species, and laboratory animals.

The work of the VDL is carried out by more than 50 individuals, including residents, technicians, support staff, and faculty members from all three academic departments in the College.

#### I'd like to update you on some of the newer services currently offered:

The molecular diagnostics section began soon after the appointment of Dr. Carol Maddox four years ago. With leadership from both Dr. Maddox and Dr. Gail Scherba in virology, it recently introduced tests for bovine viral diarrhea virus (BVDV) and porcine respiratory and reproductive syndrome virus (PRRSV) using highly sensitive real-time reverse transcription polymerase chain reaction (qRT-PCR) methodology.

Same-day results are available for pre-breeding semen testing for PRRSV, and there is a 24-hour turnaround time on tissue and serum samples. The BVDV test detects types I and II genomes in both acutely infected and persistently infected animals, with a response time of 36 hours. This relatively fast, accurate, and affordable testing will be key for achieving the goal of eradication of these economically crippling diseases.

Dr. Maddox is also excited about real-time PCR tests for leptospira. It allows the detection of leptospira in urine during the acute disease phase, a huge leap forward over serology tests that weren't sensitive until weeks after the initial infection. The new test has identified cases of chronic leptosporosis that had gone undetected by conventional serology. Because this organism impacts species ranging from dogs to people to livestock and wildlife, rapid and highly sensitive identification means greatly improved treatment outcomes and reduced risks of disease spread. For both leptospira and PRRSV, positive PCR test results can be followed with gene sequencing to differentiate vaccine-related and wild type serovars and help practitioners effectively treat and manage the cases.

Several other molecular assays are currently offered by VDL: campylobacter detection and speciation, Clostridium perfringens toxin typing, E. coli virulence testing, Listeria monocytogenes detection, mycoplasma detection and speciation, salmonella detection, and Streptococcus equi detection and typing.



In VDL's clinical pathology area, Dr. Anne Barger reports that a new D-dimer pointof-care test kit has replaced the previous standard FDP test for diagnosis of thrombotic conditions. Through the cytology service, immunocytochemical staining for lymphomas is now available.

In all areas of VDL, the goal is not simply to provide diagnostic results, but to provide rapid, accurate results in a context of clinical relevance, with support for interpretation and application of the information to the situation at hand. VDL also plays an important role in research activities and in the training of veterinary and graduate students.

Now after all this news about what the VDL can do for you, here is one reminder of a service it cannot provide: carcass disposal of pets, wild animals, or any animal that has not been submitted for clinical or diagnostic evaluation through either the diagnostic laboratory or the teaching hospital.

## AWARD WINNERS AT 85TH ANNUAL U OF I FALL CONFERENCE

Three veterinarians, one community leader and three students were honored jointly by the University of Illinois College of Veterinary Medicine, its Veterinary Medical Alumni Association and the Auxiliary to the Illinois State Veterinary Medical Association on October 14 during the college's 85th annual Fall Conference for Veterinarians. Honored recipients were bestowed with the Dr. Erwin Small Distinguished Alumni Award, the Special Service Award, and tuition scholarships.

Charles Wiedmeyer (DVM '94), president of the UIVMAA, presented the Dr. Erwin Small Distinguished Alumni Award. The award, given by the Veterinary Medical Alumni Association, went to three recipients this year, each a distinguished Illinois graduate who has made significant contributions to the profession or College.

Dr. Emil Baukert (DVM '76), owner of Riser Animal Hospital in Skokie, Ill., was honored for his tireless service to organized veterinary medicine at the Chicago, state, and national level. His nomination noted that he was the driving force behind the organization of the State Emergency Veterinary Network, a means for assisting animals and owners in the event of a disaster. He was also a founder of the Chicago Veterinary Medical Association's Pet Loss Helpline and Support Group. Among many other roles, he has served as president of both the CVMA and the Illinois State VMA.

Dr. Gregg BeVier (MS '77, DVM '82, MBA '92), head of Production Animal Global Enterprise at Merial, was hailed for being a strong advocate of the veterinary profession within the animalagricultural industry as well as for being a strong advocate of the College of Veterinary Medicine. His commitment to the college's nationally recognized IFAMS (Integrated Food Animal Management Systems) and Executive Veterinary programs, through his time, money, and connections, was invaluable to the college and to the many veterinarians whose careers he inspired. He currently serves on the College's external advisory committee.

Dr. Joseph DiPietro (DVM '76, MS '80), dean and professor of veterinary parasitology at the University of Florida College of Veterinary Medicine, Gainesville, was recognized as contributing to the profession as a practitioner, researcher in equine anthelmintics, innovative teacher, and excellent administrator. Before taking on the deanship at Florida in 1997, Dr. DiPietro taught at the college for nearly 20 years and headed the college research office for three years.

The Special Service Award, given by the University of Illinois College of Veterinary Medicine, went to Harriett Weatherford. This award recognizes an outstanding individual who has made significant contributions to the veterinary profession or the college. Despite a demanding career as an administrator at the University of Illinois (she is currently semi-retired as associate director of the campus Athletic Association), Weatherford has devoted many thousands of hours and many thousands of dollars over her lifetime to support animals, through her involvement with both the Champaign County Humane Society and the College of Veterinary Medicine. She was instrumental in starting a volunteer program at the Veterinary Teaching Hospital earlier this year.

The Auxiliary to the Illinois State Veterinary Medical Association annually awards tuition scholarships to the college's students. On hand to present the scholarships were three members of the Scholarship Committee, Kelli Nichols, Kay Armbruster, and Chris Fairbrother, as well as Patty Herath, Auxiliary President. This year's \$1,000 scholarships were presented to Claire Ojala, Class of 2006, Jason Wrage, Class of 2007 and Lynette Wellen, Class of 2006.

#### NCVEI OFFERS SOMETHING FOR EVERYONE

The NCVEI's website (www.ncvei.org) was launched in 2002. The initial website featured a series of 12 benchmarking tools for companion animal practices. Since the first launching of the NCVEI's website there have been a number of changes, additions and improvements to the benchmarking models. The first improvement gave veterinarians the opportunity to enter multiple years of data into the database. Veterinarians can enter 2001, 2002 and 2003 tax year data to receive results in the form of charts and graphs not only comparing their data against other practices, but also to monitor the clinic's own progress from year to year.

A second benefit added to the NCVEI's website was the breakdown of results by state. When the website was first launched, users were provided with results comparing their clinic to other practices on national and regional levels. As more data was entered into the website, the NCVEI had the capability to break down results into a state level. As additional data is collected the NCVEI will eventually break the data down into zip codes and into types of specialty practices.

It was always the intention of the NCVEI to reach out beyond companion animal practitioners to other segments of the profession. Thanks to a grant from the AVMA, the NCVEI created a suite of benchmarking tools for equine practitioners. These eleven models offer equine veterinarians the same opportunity to benchmark their practice as their fellow practitioners working in companion animal practices. Equine veterinarians may also enter multiple years of data and, once enough data has been collected, results will be broken down into smaller demographic segments. The equine benchmarking tools were released on the website in May.

A grant from the Western Veterinary Conference allowed the NCVEI to create the first set of benchmarking tools accessible to all levels of support staff. A series of Staff Utilization tools has been created which not only address the staffing concerns of veterinarians, but also give support staff the opportunity to share information and compare their performance against employees from other clinics.

One of the key issues identified in the study, "The Current and Future Market for Veterinarians and Veterinary Medical Services in the United States" (Mega Study) was the efficient use of support staff, with a focus on quantifying the financial and professional impact of better staff utilization and delegation. The NCVEI recognizes the veterinary profession lags behind other professions in efficient use of support staff.

Mr. Howard Rubin, CEO of the NCVEI, uses an analogy of the auto racing profession to demonstrate how efficient use of staff results in success. "Racecar drivers are perfect examples of efficient staff utilization and teamwork. A racing team must hire, train and retain qualified employees. The driver must put his confidence in the team and trust they will do the job they are trained to do – his safety and his life depend on that trust. A driver would never pull into the pit during a race, get out of the car, change worn tires, fill the car with gas, wash the windshield, make engine repairs, and then get back into the car to continue the race. By not using his professionally trained team he would eliminate any chance of success in auto racing."

The conditions are the same in a veterinary clinic. By not utilizing support staff properly a veterinarian who does not delegate responsibilities loses trained employees, treats fewer patients and has less time for other practice business. Poor staff utilization results in an inefficient and less profitable practice with dissatisfied employees.

There are additional growth opportunities in the future of the NCVEI. A recent grant from the AVMA will fund the development of benchmarking tools for large animal practitioners. Work on these models will begin in the summer of 2004 and release is anticipated in 2005. Veterinarians interested in reviewing and offering feedback on these tools prior to their release should contact the NCVEI office via e-mail at info@ncvei.org. The NCVEI will also be looking for food animal practitioners who would be willing to provide seed data for these tools. #### Who Qualifies for the Welfare-to-Work Tax Credit?

To earn the new Welfare-to-Work Tax Credit, hire any member of a family: who received family welfare (AFDC or its successor program, Temporary Assistance for Needy Families, TANF) for at least the 18 consecutive months before date of hire, or whose AFDC or TANF eligibility expired under federal or state law after August 5, 1997, or who received AFDC or TANF for at least 18 months after August 5, 1997, and begin work any time after December 31, 1997 and before December 31, 2005.

#### **Work Opportunity Tax Credit**

What if employees don't qualify for the new Welfare-to-Work tax credit? They may qualify for the existing Work Opportunity Tax Credits. The maximum tax credit under WOTC has been increased to \$2,400 per new worker, calculated at 40% of the first \$6,000 in wages. You must retain the worker in your employ for a minimum of 400 hours to qualify for the full 40 percent credit. New, eligible workers working for 120 to 399 hours earn you a 25 percent credit on any wages up to \$6,000.



## ISVMA FORUM

Following are actual questions that have recently been asked of ISVMA staff members:

Q: I receive paper certificates for continuing education when I attend seminars and/or conferences. What exactly am I supposed to send to ISVMA for recording continuing education credits?

A: Each time you attend a seminar or conference and are given a certificate of continuing education (CE) credits earned, you may forward a copy of it to the ISVMA offices for recordkeeping. You can forward it either by faxing it to our office (217/ 523-7981) or mailing a photocopy of the original document to 133 south South Fourth Street, Suite 202, Springfield IL 62701. If so inclined, a scan of it can be forwarded to us by email at info@isvma.org.

Once we receive the copy of your earned CE units, we enter that information into our database which will allow us then to compile a report of total hours for the renewal period. Your document will then be filed and kept for reference.

The law specifies that each DVM is required to maintain CE records for 5 years for auditing purposes. In order to be compliant, The the ISVMA office will also keep on hand all CE documentation for the required 5 year period to be compliant. In the event of any member being audited, the ISVMA will have all documentation necessary to prove continuing education earned.

Q: I have a client who wants to travel to the UK with her dog. The recent information I have obtained doesn't seem right. It doesn't match what I know and I would like some clarification. What are the current rules for entry?

A: The rules for dogs (including guide dogs and hearing dogs) and cats traveling from certain European countries and entering the UK changed on February 28, 2000 with the introduction of The Pet Travel Scheme (PETS). PETS has since expanded to include non-European countries with mainland USA and Canada joining on December 11, 2002. It is the system that allows pet animals from certain countries to enter the UK immediately and avoid the 6 month quarantine period as long as they meet the rules.

It must be noted, however, that the rules governing the procedures for that entry are set in stone. The UK does not bend or give exemptions when mistakes are made. To meet the immediate entry requirements, a client must start at least 7 months in advance of the trip.

*Step One:* Get a microchip implanted. The microchip number is one of the most important factors for travel since it identifies the pet. It must go on all of the documents. Avid or Home Again is acceptable.

*Step Two:* Get a new rabies vaccine. This is one of the problem steps. The UK requires that the rabies vaccine be administered after the microchip is implanted. It doesn't matter if the animal still has a valid rabies vaccine.

The rabies vaccine can be given the same day as the microchip, as long as the chip is done first. It is essential is that the pet be given the rabies vaccine after being identified with the microchip as the microchip number must be included on the vaccine certificate.

The certificate must then be signed by the veterinarian, as per the USDA, to make it valid. It cannot be rubber stamped. A receptionist cannot sign and initial the signature.

A note on hospital letterhead stating that this order has been followed is extremely helpful. It leaves no doubt when the pet's paperwork is presented in London.

*Step Three:* Obtain a rabies titer test, submitted to Kansas State University. KSU is the only approved lab by the UK. (The military has it's own lab, also approved, located in Texas for military personnel.) The blood is drawn a minimum of 21 days following the rabies vaccine.

Young animals that have received only one vaccine, or immune-compromised pets, may require several rabies vaccines before they have a passing titer test result of 0.5 units. When they fail by having a titer less than 0.5, a new vaccine is given and the client must wait another month before having blood drawn for another titer test. This delays the date of entry into the UK.

After steps one through three have been completed, the waiting period begins. The pet will be eligible for immediate entry 6 months from the date the blood was drawn (not the date of the actual test, which is what some other countries follow).

In the interim, the Veterinary Certificate (or Entry Form if prior to October 1, 2004), available from the USDA can be completed and forwarded to the USDA with all the supporting documents for endorsement the rabies vaccine certificate, the microchip registration form (Avid provides one showing the date of implant) and/or a letter of verification from the vet offices as described above, and the rabies titer test results. This can be done anytime during the waiting period. Military personnel are not exempt from this step. This is often when clients find

## Tax Credits Available to Employers Hiring Disadvantaged Workers (from page 9)

Which Hires Qualify Employers for the Work Opportunity Tax Credit (WOTC)? To earn the WOTC credit, you may hire any member of a family that received family welfare for any nine of the 18 months (long-term before date of hire, OR members of the following groups: Youths aged 18-24 from families with Food Stamps, U.S. Veterans receiving Food Stamps, Vocational rehabilitation referrals, 18-24 year-olds living in Enterprise Communities or Empowerment Zones, Summer employees, 16 or 17 years old, living in one of the same special areas, Low-income ex-felons, Supplemental Security Income recipients.

#### How to Certify Eligibility for Either Credit

When a candidate is first interviewed by an employer, the employer is required to pre-screen the potential employee to determine eligibility. An employer must complete both a Pre-Screening Notice (IRS 8850) and an Individual Characteristics Form (ETA 9061) on or before the day a job offer is made. These forms must be received by IDES/IETC, either mailed or hand-carried, not later than the 21st day after the individual begins work for the employer.

In cases where IDES has pre-determined that your prospective employee is eligible for either the Welfare-to-Work or Work Opportunity Credit, that applicant is given a conditional certification document. The employer is responsible for completing the Conditional Certification and returning it to the IDES office.

#### **To Claim Your Tax Credit**

After IDES receives your completed forms, you will receive an Employer Certification. You can then claim the credit on your federal income tax return, by submitting the Employer Certification, together with IRS Form 5884.

#### How to Find Eligible Workers

Information about the Welfare-to-Work and Work Opportunity Tax Credit programs is available through a statewide network of IDES offices and Illinois Employment and Training Centers (IETC's). To find qualified tax-credit-eligible candidates, employers can use the new Illinois Skills Match or contact their nearest IETC and ask for staff assistance to locate Tax Credit eligible candidates for job openings.

#### **To Obtain Forms And Information**

Visit online at www.ides.state.il.us/employer/uitax/credits.asp and download the Pre-Screening Notice, IRS Form 8850 (2 pages), 8850-Instructions (2 pages), the Work Opportunity Credit form, IRS Form 5884 (3 pages), and the Individual Characteristics Form, ETA 9061.

out things have been done incorrectly, because the USDA office will not endorse documents if the correct procedure has not been followed.

*Before October 1, 2004,* the paperwork for the UK consisted of two separate documents: an Entry Form and a tick and tapeworm treatment document. This "old" Entry Form is still valid if it was completed and endorsed by the USDA prior to October 1, and will remain valid until the rabies vaccine expires. The old tick and tapeworm document and the health certificate may be completed to go with it; or, if desired, the tick/tapeworm section of the new document can also be completed and attached.

After October 1, 2004, the paperwork/document became a single page, two-sided form called a Veterinary Certificate. This "new" document combines the Entry Form and tick and tapeworm document and is the same for dogs, cats and ferrets. It can be completed and endorsed by the USDA up to four months in advance of travel, but it is only good for the four months. Sections I through V of the Veterinary Certificate are owner information, pet identification, rabies vaccine information and the rabies titer test results. The "official veterinarian" is the USDA accredited veterinarian performing the health exams and completing the certificate. The "endorsement by the competent authority" box is where the USDA veterinarian signs and seals the document. Section VI and VII are for tick and tapeworm treatment verification. It may be completed before or after the USDA endorses the document. Be advised; however, that each USDA office may have their own procedure they follow.

*Step Four:* 24-48 hours prior to the trip, the pet returns to the veterinarian for a health certificate and the tick and tapeworm treatment. The health certificate form can be the international 7001 form, or a simple document printed off the computer. The UK Veterinary

Certificate, available from the USDA or from Airborne Animals LLC, need not be endorsed by the USDA. The tick and tapeworm section of the Veterinary Certificate form is completed by the veterinarian at this time. Droncit or Drontal and Frontline are acceptable. Cestex is not accepted by the UK. The client will need to take all forms to the airport. They will be attached to the pet's kennel for shipment.

There are approved airlines and routes the pet must take in order to qualify for immediate entry. All pets must go into London. Pets may also be shipped on unapproved airlines or routes, go into quarantine and then qualify for an early release. The release usually takes one to three days.
