I am pleased to serve as your president this year. I look forward to working with you to make our association stronger. Under the leadership last year of Dr. Tracy Myers, the association developed a new and robust strategic plan. You can find the plan on our web site at www.isvma.org.

There are a number of short-term goals and several goals that will take a few years to accomplish. One of our goals is to develop the next generation of leaders for our association and the profession. To that end, we are engaging in a leadership program. Power of 10 is a leadership training initiative designed to help recent graduates develop foundational skills in leadership, communication and business. Ten veterinarians were selected to begin the program, and they had their first meeting in November in Lombard.

A major ongoing challenge for our association is working with our legislature to provide science-based information as they respond to constituents and develop legislative proposals. We have

an excellent legislative committee chaired by Dr. Steve Dullard and experienced advocates such as Terry Steczo and Maureen Mulhall from Government Strategies Associates. There has been significant turnover in the legislature over the past few years, and a number of individuals with significant understanding of our profession have moved on to other responsibilities and opportunities. We have an opportunity now as an association to forge new relationships with legislators. It will take the efforts of individual veterinarians to get to know and interact with your local legislator. Over the next few months, we will be identifying legislators and local veterinarians and technicians from their districts, and we will be asking you to get to know your local representative. To assist you, we will provide you with a one-page fact sheet about the ISVMA and the importance of veterinary medicine to the state. We will also assist you in setting up individual meetings with your representatives in their local offices.

We look forward to hearing from you and hope that you will be actively engaged in the activities of our association.



Your Membership as a Resource

The last quarter of 2015 was a whirlwind of activity for the ISVMA Board of Directors and the staff. In addition to hosting a convention and starting the Power of 10 leadership pro-

gram, office staff members answered a multitude of questions for association members.

Finding answers to questions that occur every day in clinics is a free service offered by staff and a benefit of your ISVMA membership. On a weekly basis, our staff members answer one to five member questions by locating resources and documentation addressing each member's specific inquiry. Questions range from con-

trolled substance recordkeeping to abandoned pets to employment issues and professional licensing issues. Some of these questions are standard and easily answered while others require a few days of research. If your particular query falls into the research category, please be patient with us, as sometimes the answer to your question brings other aspects of an issue into consideration. Also, know that we will not provide legal or accounting advice but will try to find resources for you or brainstorm solutions with you.

Most recently, the staff has been talking to veterinarians about Practice Act violations. We find that veterinarians are not sure how to move forward with their concerns. Veterinarians and certified veterinary technicians can go to the IDFPR website and click on the "Make a

Complaint" form to either electronically or by fax submit information about someone who is violating the Practice Act.

ISVMA is also a resource for consumers who have questions about veterinary services. The staff often encourages consumers to review the "Find a Veterinarian" information on the ISVMA website, helping them verify that a veterinarian is in good standing by the IDFPR. ISVMA also encourages regular communication about pet health with their veterinarian.

In 2016, the ISVMA staff encourages you to consider your membership a resource to answer questions that are important to the daily operation of your practice. Questions can be sent to info@isvma.org, or you may call us at (217) 546-8381.



Four Things You Should Know About Illinois in 2016

Happy New Year from all of us at your College of Veterinary Medicine!

The start of 2016 falls midway through the fiscal and academic year at the

University of Illinois. It's a good time to update you on recent brag points, budget woes and our continuing gratitude for the partnership of the Illinois veterinary profession.

1. Illinois Students Shine

Since the results came in last fall, I have been sharing this good news widely: Our class of 2015 achieved a 99.2 percent pass rate on the North American Veterinary Licensing Examination (NAVLE). For comparison, the national average is a 95.5 percent pass rate.

Further evidence of the curriculum's efficacy comes from responses to a survey conducted just before graduation. Students who graduated in the past three years (the first classes educated under the new Illinois veterinary curriculum) reported significantly higher levels of confidence in their practice skills at graduation than did those graduating in the previous five years.

In 2015, for the first time, Illinois students and clinicians formally partnered with the state Department of Agriculture to provide veterinary care for all animals at the annual state fair. Philip Nelson, director of the agriculture department, noted, "Large animal veterinarians are critical to the livestock industry. There has been a decline over the years in this field, and this partnership serves as a way to give students another practical experience."

Another stellar student, Matt Holland, class of 2017, is leading on a national level. He is serving a three-year term — one year each as president-elect, president and past president — on the Student American Veterinary Medical Association Board.

2. State Budget Binds

As campus leaders foresaw problems with the state budget early last year, they asked the college to develop a plan to address a potential 31.5 percent reduction in state funding. For us, that amounts to about \$2.2 million over the next two years. We've made difficult budget choices in order to preserve a transformative educational experience for students, to strengthen research programs and to enhance referral services.

One impact of the budgetless state is that it left in limbo a major renovation project

for the two large lecture halls in the Basic Sciences Building. All state-funded construction activity halted on July 1, leaving our 240 first- and second-year classes with nowhere to sit during 20-plus hours of lectures each week.

In a little over a month, we evaluated many options and quickly implemented AV improvements so that the microbiology and anatomy laboratories could accommodate the entire classes for lectures. The result is cramped and awkward, but it allows students to remain on the veterinary campus, and it retains, for the most part, the established class schedule.

3. Resources for Referrers Grow

Despite budget constraints, the college is committed to providing outstanding clinical and diagnostic services for veterinary professionals. Last year, the Veterinary Diagnostic Laboratory (VDL) began offering rapid and inexpensive microbiological identification with a new Bruker MALDITOF Biotyper. By the end of 2016, we

anticipate having a fully operational 3T MRI unit that will enhance service from our neurological, oncologic, equine and other Veterinary Teaching Hospital (VTH) sections. A search is under way to hire a second cardiologist to complement the work of Dr. Ryan Fries, the only boarded cardiologist in the state who performs interventional procedures such as balloon valvuloplasty.

In Chicago, clinical pathology services are now available through our satellite VDL location in Buffalo Grove. Specialty and emergency veterinary services are offered in the city at VSC at Illinois. The college is using both of these locations to expand scholarship and research opportunities in addition to providing service.

Lastly, a free mobile app for referrers was recently launched to make test results and contact information from the VDL and VTH easily accessible. Get it from your app store by searching for "Illinois DVM."

The Illinois State Veterinary Medical Association (ISVMA) is a member-driven organization. This means it is the responsibility of your elected Board of Directors to represent the needs of ISVMA members in their constituent regions and the responsibility of the ISVMA staff members to implement the directives of the Board to the best of their abilities.

To that end, the ISVMA Board of Directors met in a special session this June to chart a three-year course of action for ways in which our organization can better serve its members. Board and staff members spent one and a half days with a facilitator to address areas of potential improvement, specific needs within those areas, and ways in which the ISVMA staff and volunteers can work to create an even better voice for our profession in Illinois.

The strategic plan outlined on the next page is a culmination of this hard work. The Board defined five basic areas on which to focus our efforts over the next three years, then brainstormed ways to improve our services in those areas. Finally, the group addressed implementation of these ideas, as well as benchmarks to evaluate the progress toward these goals. Member feedback over the next three years is crucial as well.

In addition to the strategic plan overview, there are detailed plans in all of our five areas of focus for each of the next three years. In year one, the general goal for advocacy is to clarify our message to legislators and help educate them on generalities of veterinary medicine and animal health. Efforts by individual members to reach out to their local officeholders will be critical to achieving this goal.

Professional development plans for year one include exploring new options for continuing education that better serve our membership's needs, as well as improving the appeal of our current offerings. Clarification of CE guidelines will also be addressed.

The ISVMA strategic plan gives the organization the framework to grow and continue to better serve its membership.

Membership's mission for year one will be pursued by determining the unmet needs of the diverse membership base, then using demographics and other measures to promote these new services to the members.

Regarding public awareness and community relations, awareness of our profession will be improved by keeping the general public better informed on veterinary and animal health issues. We will explore creative ways to reach out to all audiences.

Finally, we hope to improve our association strength in the first year of the strategic plan by determining our industry and association allies for promoting ISVMA's goals throughout Illinois and strengthening our relations with them.

The strategic plan is a fluid document; as the association progresses through the stages of implementation, some readjustments may be needed, as with any business plan. However, the ISVMA strategic plan gives the organization the framework to grow and continue to better serve its membership. The combined efforts of staff, Board members and other volunteers will help ensure continued progress toward these goals.

The Convention is also the time when the profession recognizes its own by presenting several awards for service, as well as holding its annual meeting.

The 2015 Dr. Erwin Small First Decade Award winner is Dr. Jamie Shertz, who is a 2006 graduate of the University of Illinois. She is a small-animal veterinarian who practices at Town & Country Animal Hospital in Normal. She has served on the ISVMA Education Committee, which plans the ISVMA Annual Convention. She was also a student representative to ISVMA during college. Dr. Shertz regularly visits grade school classrooms in the Bloomington-Normal area to talk with children about veterinary medicine and safe animal handling.

The Dr. Cecil Ingmire First Decade CVT Award is given to one certified veterinary technician who has graduated within the last 10 years and has demonstrated a strong commitment to the profession through involvement in organized veterinary medicine. The award is named after Dr. Cecil Ingmire, whom many refer to as the "Godfather of Veterinary Technology" in Illinois. His involvement and leadership with the programs at both Parkland College and Joliet Junior College have been instrumental

to those programs graduating outstanding veterinary technicians.



Renewing Your Lease: Important Things to Know

Leases and lease renewals are not typically conducted on a level playing field. After all, the landlord is in the real estate business and most doctors are not. By planning ahead and having professional representation, it is possible to negotiate a lower lease rate and receive a substantial tenant improvement allowance and free rent.

How does the lease renewal process work?

An important clause found in a standard lease is the renewal option. This allows you to extend your lease for a predetermined amount of time (often three, five or 10 years) by giving your landlord advance written notice. Renewal options include terms for specific lease rates, concessions such as free rent and tenant improvement allowance, and whether a new base year for operating expenses will be granted. Whether or not a renewal clause exists in the original lease, all of these terms are negotiable and play a large role in the financial structure of a lease renewal. Renewal negotiations are most effective when they are conducted in the proper timeframe, have multiple viable relocation options, and create a strong posture to maintain the upper hand.

When should the process begin?

As a rule of thumb, you should begin to consider the renewal process 12 to 18 months in advance of your lease's expiration. This is recommended so that you can compare all relocation options in the market before your current lease options expire. Tenants who miss their lease options incur more risk. Landlords view this as an opportunity to push rents higher as the window of opportunity to relocate closes. If tenants holdover (stay in the space after the lease expires), they often see penalties of 150-200 percent of their last month's rent and can also incur damages if they holdover without permission. The bottom line is that, if there is not ample time to relocate if necessary, the landlord has a strong upper hand.

What type of cost savings can be achieved through a successful renewal?

If properly negotiated, you can achieve significant rent savings, a buildout allowance, free rent and other concessions. It is very common to start a lease-renewal term at a lower lease rate than what you are currently paying. In many markets, landlords are offering aggressive concessions and more attractive lease terms to good tenants to keep their buildings leased and avoid vacancies. The amount of overall savings will depend on the availability of competitive vacancies, the efficiencies of the buildings, and your market knowledge and ability to negotiate business points.

What are some common mistakes practices make during the process?

One of the most common mistakes practices make is negotiating without the help of a commercial real estate professional, specifically one who specializes in representing health care providers. Some believe they can save money by not using an agent, but to benefit in real estate, leverage is the key to posture. Landlords are in the real estate business and negotiate with professional guidance. Selecting an expert to represent you provides the leverage needed to receive the best possible lease terms. Further, landlords are typically responsible for paying commissions so professional representation is available to you at no out of pocket cost.

Another mistake practices make when entering into a lease-renewal negotiation is not being familiar with their current lease terms and risking exposure. Prior to contacting the landlord about a lease renewal, you should be well aware of your current lease terms including every option and deadline. Most leases contain options that must be exercised within a specific time period, typically six to 12 months prior to the lease's expiration. If you allow this period to pass, you risk losing all rights outlined in the option, which can cause the negotiations to begin at a disadvantage.

How do I calculate what I am currently paying per square foot?

Knowing what you are already paying per square foot is especially important if you are thinking about renewing your lease. What you are paying now versus what buildings are leasing for in your immediate area can be vastly different, especially if your lease has had automatic escalations in the rate over the term of the lease. The way to calculate your price per square foot is to multiply your monthly rent by 12 months and divide it by your square footage. Keep in mind that NNN or CAM charges (operating expenses for the property) are also calculated in the same manner.

Summary

Successfully negotiating a lease renewal is more than bartering, bluffing or asking for a good deal. Landlords, and their professional representatives, are in the full-time business of maximizing their profits, even if it means taking advantage of uninformed tenants. You can level the playing field by engaging your own professional representation, gaining competitive market knowledge, and having multiple options for your office space. When done properly, a well-negotiated lease renewal can have a dramatic impact on your practice's profitability.

Important for All Licensees from IDFPR

The Illinois Department of Financial and Professional Regulation (IDFPR) upgraded its website. Licensees are now able to update contact information at any time. - Click the link at the top of the screen that says, "Click Here to request a License Reprint or to Change your Address, Email Address or Telephone Number."
- 3. Select your profession in the first dropdown box.
- Make sure that "Change/Verify Address & Contact Info" is selected in the "Select Reprint Reason" dropdown box.

- 5. Enter your licensee number, U.S. Social Security number and date of birth.
- 6. Click "Search."
- Once your information has been found, it will be displayed, and updates can be made to phone number, email and address fields.
- 8. Make the desired updates, and click "Save and Continue" to lock them in the system.

Other website features allow veterinarians and certified veterinary technicians to renew their licenses during the appropriate timeframes. Veterinarians may also renew their Illinois controlled substance licenses online. License reprints can be requested online, too. You may also notice there is a place to make online complaints, if you have firsthand knowledge of an individual violating the Veterinary Practice Act. This form can be used by professionals. It is not just for general citizens with a complaint.




