

## **House Bill 315 Passes Illinois House Executive Committee**

HB315 was amended by the ASPCA and passed the Illinois House Executive Committee on a 10-1 vote on March 2, 2005. The bill will now be voted upon by the entire House of Representatives. Dr. Stephen Dullard, a member of the ISVMA Board of Directors and Legislative Committee, testified in committee in opposition to the bill. Despite his excellent, scientifically-based presentation, the strong emotional arguments of the bill supporters resulted in the discharge of the bill from committee.

House Bill 315 is now referred to as "Anna's Bill." The bill is named after Anna Cieslewicz, an Evergreen Park woman, who died after two stray dogs attacked her while she jogged through the Dan Ryan Woods.

The ISVMA continues to oppose House Bill 315. The recent amendment to the bill includes a provision that further demonstrates the supporters' willingness to ignore science and the threat of a deadly zoonotic disease in their desire to pass the bill:



The bill now EXEMPTS farm dogs from any registration required by a county. These animals, which run a heightened risk of rabies exposure, would longer be required to be vaccinated!

We need every ISVMA member veterinarian to contact their state representative and state senator to explain our opposition. ### **From the Point of View of an ISVMA Life Member**

One of ISVMA's Life Members recently corresponded with his legislators regarding HB315. He made some points that I hope we all can reflect upon:

*"I wish I could have taken you along 25 to 30 years ago when I went through the chairs of the Illinois State Veterinary Medical Association. It was organized veterinary medicine that made possible the eradication or control of a long list of zoonotic and/or economically devastating diseases. The status of the profession and support from legislators has declined alarmingly in the last decade.*

*"At the (Western Veterinary) conference I spent a morning in sessions on emerging zoonotic diseases. In a changing*

*world as isolation of diseases becomes more difficult worldwide and bio-terrorism has become a real fear we may need far more veterinarians than we are generating."*

Every legislator should be made aware of the vital role veterinarians have in developing effective policies for animal care and welfare - and public health. Lawyers and advocacy groups do not have the scientific training and background to set the policy agenda and veterinarians must become more politically engaged to prevent them from advancing a sometimes dangerous and economically devastating agenda.
