## New "FairPay" Overtime Rules Will Affect Most Veterinary Practices

Overtime law is undergoing important changes that will affect most veterinary practices. Known as the FairPay rules, these regulations took effect August 23, 2004.

To offer their members a better understanding of the new FairPay rules, the Massachusetts VMA asked attorney Todd Newman of Hanify & King P.C., to summarize what veterinarians and practice owners need to know about the new law. Mr. Newman specializes in business litigation and labor and employment law.
