Status of ISVMA Supported Legislation

The ISVMA has reported in previous issues of the E-SOURCE about the status of [House Bill 4843](#) (The Veterinary Student Loan Repayment Program Act) and [House Bill 4391](#) (The Internet Prescribing Prohibition Act). Both of these bills include provisions introduced and supported by ISVMA and easily passed in the House of Representatives in early April.

The bills must now be heard and approved by the Illinois State Senate. *Normally*, bills that are so favorably viewed (each has a substantial list of sponsoring senators) move quickly through the Senate hearing process. As you probably know from reading your local newspaper, however, this legislative session is anything but *normal*.

The House Speaker required an amendment be attached to bills that passed the House of Representatives. The "rules language" required by the Speaker is intended to limit the Governor's flexibility in the promulgation of rules used to implement new legislation.

It is believed that the house amendment is the impediment to most House bills being posted for committee hearings in the Senate. The Senate President is very cool to the Speaker's amendment; and the few House bills that have received hearings in the Senate have removed the House language. The House Speaker has given no indication that he will recede from his amendatory language; thereby establishing a legislative "Twilight Zone" that has literally created a work stoppage in Springfield.

We are caught in a real true "Catch-22": no legislation was allowed to pass the House without the Speaker's language attached; and no bill can be considered by the Senate with the Speaker's language included.

The ISVMA is continuing to work for a resolution that will allow these bills to be called for a vote in the Senate and, hopefully, be approved into law by the Governor. We will provide additional updates on these bills and other issues when the legislative logjam is finally resolved.

About the Photo

The [White-eyed Vireo](#) (*Vireo griseus*) is a medium-sized, secretive vireo with olive-green upperparts, and white underparts with yellow sides and flanks. It has pale yellow spectacles its iris is white. It has dark wings with two white bars and its legs and feet are gray. The White-eyed Vireo flies fast and direct on its short, rounded wings; but despite the physical description, the White-eyed Vireo is more noticeable for its explosive song than its looks.

This regionally abundant species breeds from Nebraska to Massachusetts, south to eastern Mexico and throughout Florida. It winters from the southern Gulf Coast to Central America and from coastal North Carolina, the Bahamas, and Bermuda to the Caribbean. It is found in dense thickets, pine flatwoods, cypress swamps, and scrubby edges of roads, canals, and ponds. It avoids urban areas, but may be found in wooded parks and undeveloped areas near and within large cities.
