

Clarke Atkins, DVM, ACVIM

Dr. Atkins, the Jane Lewis Seaks Distinguished Professor of Companion Animal Medicine (Emeritus) at North Carolina State University and 2004 Norden Outstanding Teacher Award Winner, is board-certified by the ACVIM (Medicine & Cardiology). He has served on 4 ACVIM or international Consensus Committees on systemic hypertension, canine mitral valve disease, and cardiorenal syndrome.

Dr. Atkins research involves canine and feline heartworm disease and treatment of cardiovascular disease in dogs, cats, and horses. He has over 150 publications and has

provided well over 1000 hours of continuing education in the U.S. and many countries around the world. Dr. Atkins continues to be active speaking and carrying out clinically-oriented research in retirement.



Debra Olbrich, DVM, MS

Dr. Olbrich is a senior professional services veterinarian with Merck Animal Health and covers both Illinois and Iowa. Prior to her role at Merck, she obtained her master's degree from Northern Illinois University which is where her interest in parasites first started. Her master's thesis focused on parasitoid wasps that she collected at her family's dairy farm.
