For Animal Owners

When To Suspect A 💡 Foreign Animal Disease

- High morbidity and/or mortality
- High abortion rates of unknown etiology
- Severe respiratory conditions
- Vesicular condition of any type
- Poor to no response to conditions when response is anticipated
- Recent foreign travel, foreign visitors, or receipt of foreign parcels
- History of importation of animals, embryos, or semen
- Undiagnosed central nervous system conditions
- Presence of exotic flies, mites, ticks. larvae
- Unusual or unexplained signs of illness
- Atypical findings at necropsy

If an animal owner suspects a foreign animal disease or any unusual disease symptoms in their herd, they must contact their veterinarian immediately.
