Clear, inclusive titles provide greater clarity, understanding and value while enhancing public trust.

Non-certified professionals play vital roles throughout veterinary medicine. They are essential and highly skilled team members in companion animal, equine, exotic and food animal care, as well as in research, education, zoo, wildlife and aquatic medicine - and even in industry roles like sales and support. Veterinary medicine is truly a team-driven profession!

- CERTIFIED VETERINARY TECHNICIAN (CVT)
- VETERINARY TECHNICIAN (VT)
- VET TECH
- TECHNICIAN
- Graduate of an AVMA-accredited veterinary technician program.
- Passed the VTNE (Veterinary Technician National Exam).
- Healthcare professional licensed by the IDFPR. License display is required by law.
- Completes required continuing education to maintain licensure.
- Must adhere to supervision guidelines & tasks in the Veterinary Practice Act.

- VETERINARY SUPPORT STAFF
- VETERINARY ASSISTANT
- TITLE MAY VARY BY PLACE OF EMPLOYMENT
- Completed training while working on the job in a veterinary setting.
- Vital and valued member of the veterinary team.
- Not required to attain or maintain licensure to perform their role.
- May attend continuing education for professional growth and development.
- Must adhere to supervision guidelines & tasks in the Veterinary Practice Act.

PREFERRED TERM FOR TEAM MEMBERS WHO ARE NOT DVMS OR CVTS

The title "nurse" and any variation of this title is protected in Illinois and should NOT be used to describe any member of the veterinary staff. Use of the nurse title could lead to disciplinary action against a DVM or CVT who authorizes or uses the title to describe their position.
